Ashani's mother has told her that women who work with her, always change their hand bags according to the latest styles.

Ashani determined to start a business of making ladies' hand bags and to expand it up to the international market one day. She expects to obtain a loan of Rs.500 000 at 6% interest per annum under the proposed loan project introduced by the government for encouraging the small scale entrepreneurs and to invest Rs.200 000 received from her parents for the business. Ashani hopes to do the followings for her proposed business.

- To buy two machines each Rs.75 000
- To get a building under a monthly rent of Rs.25 000
- To recruit two employees for making bags and to pay a monthly salary of Rs.40 000 for each
- To buy a laptop computer of Rs.100 000
- To advertise her products by using leaflets and social media and to get the orders through online and sell them
- To get the service of her brother Bhanuka who has a good knowledge of ICT and to pay him a monthly salary of Rs.30 000
